1. Course Overview

This course will provide with students opportunities to critically read and interpret social science literature on human capital development over the life cycle. It will also give students an opportunity to discuss, through examples, how this evidence could be applied in the real world policy design. The questions to be addressed in this course focus on human capital development such as health, education, and labor policies over the course of one's life. The examples will help students understand how to interpret available data and use it to evaluate different policy programs.

2. Course Objectives

The course has the following objectives. First, it aims at challenging students to critically think about social policies in health, education, and labour area, and draw conclusions based on empirical data. Second, the

course aims at providing several examples of real-life policy designs and allow our students to understand benefits from the methodologies developed and used in economics and social sciences to evaluate social policy programs. Lastly, this course aims to discuss strengths and weaknesses of different social policies based on supporting evidence with data.

3. Student Learning Outcomes

- 1) Analyze findings and perspectives on social issues of human capital development (health, education and labor) around the world. (SILO 1, 2, 3)
- 2) Use economic research findings to propose suitable policies to tackle real-world problems (e.g. importance of early childhood environments and investments, gender inequality, job protection program, and COVID-19 policies). (SILO 1, 2, 3)
- 3) To develop interpersonal skills: Communicate to a large audience by presenting and justifying ideas on public policy using the statistical evidence. (SILO 1, 2, 3, 4, and 6).

5. Course Requirement and Grades

1) Policy recommendation papers (30%)

You will select two topics out of six topics we will cover in the course. To write policy recommendation papers, you need to select one country (for example, Hong Kong, Macau, Mainland, Taiwan, Korea, Japan, India, and others where you are originated from). You will summarize current related policies of the country you select, and discuss how to reform the policies based on the evidences we study assuming that you are a prime minister. You could find further evidence to support your arguments. You may also want to discuss how to raise fund (or collect tax) to implement your suggestions, but this is optional. Policy recommendation paper will be maximum five pages (single, font size 11, include max five tables and figures).

2) Presentation (10%)

You will select two topics that you will potentially present in the classroom. I will then select one topic for

you, and form a group of students to work together for the presentation. The presentation will be around 20 min for each team including Q&A and discussion. Presentation slides must be no longer than 20. I encourage you to drop by my office hour to prepare the presentation properly.

3) Exam 1 (30%) – March 23 (during class time), and **Exam 2 (30%)** – May 11 (during class time)

Exam format is not determined yet. Exam is less likely to be multiple choices questions, but more likely to be open ended questions to make your own argument. You must be able to make your argument based on scientific evidence.

4) Class participation (5%)

I will also give one point for your class participation. For example, you will receive a point for a good question or comment that you could make in the classroom. It will be maximum five points over the course.
